Is-Sindku ppropona li ssir sospazzjoni ta' l-Aġenda sabiex l-Accountant tal-Kunsill jkun jista' jispjega fid-dettal ir-Rapport Finanzjarju għas-sena 2022. Il-Kunsillier P. Fenech issekonda din il-proposta. Il-ħin kien 16.22.

09.12.21 – PA information meeting re ex Halland development

Together with Perit Rossignaud I attended this on line information meeting

The developers presented a new application. This new application contains minor cosmetic changes which in my opinion were made so as to supersede the original application against which we had appealed. We argued that this new application should not be considered before the appeal of the previous application is concluded.

16.12.21 – PA hearing re New ‘Halland’ application.

Perit Rossignaud will elaborate further about this hearing. In a nutshell Perit Rossignaud on behalf of the Swieqi Local Council, Perit Valentino and Perit Cachia Fearne presented their solid arguments against the project. They insisted that the board should not take a vote before the appeal against the first application is heard. Unfortunately all the board member voted in favour of the project.

What I cannot understand is why none of the original objectors presented an objection or even participated during this hearing.

16.12.21 – locality meeting

The annual locality meeting was held. It was presented on line and my report is attached

20.12.21 – Council Christmas drinks

Christmas drinks for councillors, staff and guests were held at Madliena Cottage. Well done to vice mayor MaryAnne Abela for organising this enjoyable evening.

06.01.22 – Meeting with Hon Herrera

This meeting was meant to be held in Hon Herrera’s office in Valletta. On last minute I asked whether we could hold the meeting on line to which the Hon Minister acceded. In attendance the minister’s private secretary, Mr Muscat and Local Councils Director General Mr Natalino Attard.

I informed the Hon Minister that local council was very unhappy about the fact that basic services that were offered from the local council were stopped abruptly, thus the service of the ‘Berga’, Social Services and Immunisation. The DG will be looking into the matter and will revert.

We also discussed issues that had been brought up during previous meetings held and which were still unresolved, thus the issue of the boundary wall in Triq Wied id Dies, the acquisition of the land adjacent to the local council and overdevelopment.

With regards to the boundary wall in triq Wied id Dies, we agreed to present the Ministry with the report that had been prepared by Architect Dieter Falzon and they will take it from there. They plan to involve departments that may have an interest in these repairs, such as Infrastructure Malta and their own Heritage unit. It is important that we keep the ball rolling.

Re acquisition of the land adjacent to the local council, they plan to set up a meeting with officials from the Planning Authority and the local council so as to explore the possibility of the land being purchased.

The report that I presented to the Hon Minister is attached.

06.01.22 – meeting with Enemalta

In attendance officials from Enemalta, including the area manager, Mr Stephen Farrugia, Mr Mario Galea from Galea Curmi, Councillor Rowena Scicluna, the Executive secretary, Mr Vince Tanti, and Ms Dona Ellul and Ms Clarissa Schembri from the council staff.

We discussed issues that have been arising particularly faults that are taking a long time to be repaired. Mr Farrugia admitted that during recent months there were several changes in Enemalta and this together with damages caused by the very bad weather did not help to improve matters.

It was agreed that we present a detailed list of outstanding faults and these will be tackled as soon as possible.

Other Matters

Christmas Activities

For the first time the local council prepared a program of activities that spanned over 6 days, from 10/12/21 to 15/12/21.

I would like to take the opportunity to heartily thank all the Councillors, ably led by Vice Mayor MaryAnne Abela and Councillor Paul Fenech, the Executive secretary and the Council staff and the coordinator Mr Keith Muscat for the hard work that they put in so as to organise these events.

The first time always is always a very stiff challenge since you are treading in the unknown, especially for a locality like ours where we do not have the assistance of festa organisers, band clubs etc

The activities held were varied and appealed to all age groups. Residents appreciated the Christmas spirit that we managed to create. We should build on the knowledge acquired.

I suggest that we organise a meeting during which we will make a 'post mortem' of the activities held and see what should be retained, what should be corrected and what should not be repeated.

Christmas Decorations

I also wish to thank contractor Noel Borg for the Christmas decorations that he put up. They certainly helped to increase the Christmas spirit.

Road Works

Triq is Sidra – only this afternoon we received information from Infrastructure Malta that roadworks in triq is Sidra are planned to start by the end of next week.

This is good news since this road is in an awful state. Since the road has an overload of traffic we need to coordinate the traffic flow until works are carried out.

I have asked the Executive Secretary to coordinate a meeting with the architects in charge so as to see how they plan to coordinate works.

We need to inform the residents about the planned works.

Triq Tal Franciz

Triq tal Franciz is now fully accessible since the middle part of the road has finally been completed. We thank Infrastructure Malta for the works carried out. The stretch of the road from V Menville to triq il Mizura will be 'one way up' hence all traffic coming from the valley and heading towards upper Ibrag can now pass from this road and avoid using triq il Keffa.

Works on the lower part of triq tal Franciz, that is the section from triq il Qasam to triq V Menville will be starting soon. In this case the drainage system needs to be repaired/replaced.

Other road works

We are in contact with Infrastructure Malta to plan road works that are necessary in Triq l-Ilqugh, part of Triq il Mizura, part of Triq il Hemel, triq il Hawt and others.

Capital Projects

Gnien Esprit Barthet

Enlargement and embellishment works in Gnien Esprit Barthet are progressing at a snail's pace.

covid is not helping to expedite matters since some of the workers had to quarantine.

Extension of the Club House

Construction works have been completed. Hopefully the works will be completed in a few months time.

Gnien Maurice Caruana Curran

This garden needs to be upgraded. The gazebo must be replaced and we also need to replace the slide that was removed. I am hoping to obtain the necessary funds to finance these expenses. We have identified an area next to the club house where we plan to develop a 'toddlers' area similar to the one that there is in Gnien F X Ebejer.

I am of the opinion that the entrance to the garden be upgraded too. We still need to decide what will be done in the corner where there once were the steps.

Ibrag road Embellishment

I ASK THE Executive secretary to give us an update about the state of this project and whether we have been given the green light by all entities concerned to carry out the works.

Once the works in Gnien Esprit Barthet are completed/ nearing completion we should start concentrating on this project.
