Chetcuti ssekonda.


57.2 PUNTI LI JOHORĠU MILL-MINUTI





Mr Azzopardi, who is a resident in the locality, has identified ways and means how to improve the environment by making use of products that are environmentally friendly. We discussed the possibility of cooperating so as to help him promote his products.

11.07 – Enemalta CEO - on line meeting

A call from Enemalta informed me that the CEO wanted to meet us on an on line meeting. Even though I was not aware and hence not prepared for the said meeting I did not refuse the opportunity to meet the CEO, Mr

We discussed the issue re electrical repairs and new installations, the problem that we are facing when wall lights are removed on account of new developments, the issue that temporary poles take a long time to be removed, the problem of electric cables passing in front of newly built apartments as well as the possibility that they help us

to embellish Swieqi road by arranging the maze of wires that there exist in this road.

11.07 – Regional Meeting re Charging Pillars

Due to the increase in EV' s, Enemalta needs to increase the amount of charging pillars.

There should be 1 charging pillar per 10 electric vehicles.
We asked Enemalta to turn take over the GO TO charging stations.

18.07 – Site meeting with Perit Albert Spiteri and Contactor re Mizura road works

In attendance IM architect Mr Albert Spiteri, the contractor Mr Desira, and the Executive Secretary Ms Clarissa Buhagiar.

The works that need to be carried out were discussed . these include repairs to a section of the drainage – from Ibrag road to the foot of Triq il Kartocc, the replacement of household mains, the reconstruction of foot paths, scarifying, laying and compacting sub base material and eventually the laying of tarmac.

Works will be divided in two sections – from triq tal Franciz to triq il Mezza and from triq il Mezza to triq l-Ibrag.

We insisted that once works will commence, the contractor will not abandon the site. we also asked for proper traffic deviation via triq il Mezza, Triq F Assenza and triq il Pjanta/Kartocc.

During the time spent in triq il Mizura we were impressed with the volume of traffic that passed through this road from Ibrag road and down F Assenza and Keffa. Practicaaly no vehicles driving down Ibrag road proceeded towards l-Uqija/Jeesie' s bar.

This proves that once the right hand turn from near Jessie's Bar was closed, residents are seeking alternate exits.

Other Matters

Road Works

Triq is Sirk & Migbed

The first layer of tarmac in triq is Sirk has been laid. It appears that it will take some time until the second layer will be laid since Enemalta needs to carry out some works.

Considering the length of the job, the time taken by the contractor is commendable.

However a greater effort had to be made so as to reduce the amount of dust left in the road.

It must also be noted that a new planter was built in the corner Sirk/Gejza and 4 trees have been planted.

Comments from residents once the works were completed were very encouraging.

Triq il Hemel

Works on Hemel are progressing at a very slow pace and this is annoying residents. The household water mains have been replaced. Some drainage repairs need to be carried out close to triq il Gwielaq.

We have been pushing IM to ask the contractor to accelerate works.

Triq il Mizura

Today Clarissa and myself met the architect in charge and the contractor. Hopefully works will commence this week. They will be carried out in two phases, from triq tal Franciz

to triq il Mezza and from Mezza to Ibrag road. drainage repairs need to be carried out from Ibrag road till the manhole at the foot of triq il Kartocc.

Triq il Qasam

Parts of triq il Qasam are caving in, particularly the section between triq is Sejjiagh and triq l-Imghazel. I have asked IM to help us carry out the repairs required and they acceded to our request. They will give us their feed back once they inspect the site

Capital Projects

Embellishment Gnien Maurice Caruana Curran

Now that the contractor has been selected, we need to wait for 10 days so as to see whether anyone will object. If there will not be any objections we will meet the contractor and agree on a work schedule.

Club House in Gnien Maurice Caruana Curran

Works are grossly behind schedule. According to the contractor he is fixing the railings.

We may consider taking legal action against the contractor so as to cover our selves against any claims that may be presented against us.

Embellishment Ibrag road

The tender had to be re issued due to a technical problem.

Slow Streets

Our plans for the project have been presented to the Minster for Transport.

Electrical repairs

Garbage Problems

Now that the summer season and hence tourism are at their peak so has the garbage problem reached a horrible and unsustainable peak. This is totally unfair on the

locality and it is bringing about great frustration among residents.

The local council has been battling the lost battle for six years, ever since we introduced organic waste separation. We know the cause of the problem and we have solutions. We have regularly reported these problem to the authorities and to date not only hasn' t a solution been found but the situation is getting much worse because the number of short let apartments have mushroomed.

I must state that most of the owners/administrators of apartments follow the rules and they do not cause any problems and for this we thank them. However there are several others who are causing a terrible mess. This is not right and it must be solved.

We are of the opinion that we should be consulted about this huge problem. We have asked for a meeting with ERA and MTA.

Who defends residents ?

Mini Market in triq is Sidra and dust in Upper Ibrag road - Ombudsman

Mini Market

As already reported Daves Mini Market in triq is Sidra is opening 24 x 7. We all know why this Mini Market is opening 24 x 7. Surely no one goes to buy bread and milk or flour at that time of the day.

This outlet is serving as a meeting place for youngsters who would otherwise not be allowed in bars/pubs at that time of the night/early morning. We have evidence of beer bottles being left in the road as well as photos of groups of people gathering there.

This is annoying residents a great deal. The local council is dead against that outlets open 24x7 particularly when these are situated in residential areas, such as triq is Sidra.

We have discussed this issue with the police many a time and each time we were informed that since the removal of operating licences the police are not in a position to intervene so as to stop the mini market from operating 24x7.

So who / which authority is in a position to defend residents ? why shouldn' t a local council have a say in such issues/matters ?

For this reason this week we wrote to the Ombudsman so as to seek assistance.

Dust in upper Ibrag road – on the way to Mekkek bar

Surely everyone has noticed the volume of dust that has accumulated in this section of the road. We all know how harmful dust is to ones health. We are also aware that this dust is the result of industrial activity that takes place in the area.

We have written to the ministry for the Environment and to ERA for assistance and we did not receive any concrete assistance. Hence we reported the matter to the Ombudsman who once again referred the matter to ERA. We met officials on site and they obviously could not deny that there was a volume of dust gathered on the side of

the roads. The reply that we received from ERA basically said that there is nothing that they could do.

So the question arises once again – who defends residents ?

So we have once again written to the Ombudsman and we put forward this question to him.

Unfortunately, to date we have not received a reply. I kindly ask the Executive Secretary to send a reminder to the Ombudsman.

I am also of the opinion that we inform AKL and see what their opinion is.

Note – in no way do we want to stop any economic activity that is taking place in the area. What we want is that the road is swept regularly using a mechanical sweeper and that measures are taken to mitigate the dust produced by the industrial area.

Zebra Crossings

We have received a request to instal a zebra crossing in Lourdes Lane.

We consider this as a valid request and we should apply to TM to have one installed.

It must be noted that in the past we had obtained a permit to instal one, however due to the developments that took place in this road during recent years, this zebra crossing had to be removed.

Musical Instruments

Unfortunately the musical instruments that were installed in the Council garden are being played at odd hours of the night/early morning by irresponsible people and this is annoying some residents.

I' d hate to have to remove these instruments and deprive children from their use.

We could consider covering these instruments after office hours but again, a great deal of playing time will be lost during the summer time.

I suggest that we give them some more time and see what happens.

GO TO parking bays

We are of the opinion that until a decision is taken by Central Govt as to whether to revive the Car Sharing Project previously operated by GO TO, the signs informing the public that certain parking bays are reserved for GO TO cars only should be covered so as to allow people to park their vehicle in these bays.

Garbage Bins

We need to instal more bins in the locality. We have asked Clean Malta for a donation of bins and they have accepted to offer 6 bins. We thank them for their assistance.

I am very annoyed at the fact that the bins in Swieqi road are always tilted open. Chris maintains that these are being left open by people who fetch plastic bottles.
