

58.2.1 Il-Kunsillier T.Valentino irreferiet għaċ-ċerimonja ta' Ġieħ is-Swieqi fejn infurmat li din hija ppjanata li ssir fil-bidu ta' Ottubru u li hekk kif id-data preċiża tkun deciza, il-Kunsillieri se jiġi nfurmati mal-ewwel.

58.2.2 Il-Kunsillier T.Valentino staqsiet jekk kienx hemm xi progress rigward is-sejha ta' l-offerti dwar il-proġett ta' Madliena Enviromental Trial. 58.3.3 Is-Sindku informa li huwa flimkien mal-Kunsillieri T.Valentino, M.Bonello, A.Pisani ,



Bonnano informa li jista' jagħti l-każ li hemm xi wires li huma ta' kumpaniji privati bħal GO, Melita u EPIC u għaldaqstant jkun tajjeb li jiġu nfurmati wkoll. Is-SE infurmat li se tkun qed tagħmel kuntatt ma' dawn il-kumpaniji.

SWIEQI LOCAL COUNCIL

COUNCIL MEETING – 23.08.23

MEETINGS ATTENDED/HELD

19/07 – Meeting re Smart Waste Tender

19/07 – Regional Chess Tournament

Regjun Lvant held an outdoor chess tournament in the local council premises.

The tournament was well attended and a success

21/07 – Festa Madliena

Heartfelt congratulations and thanks to the organising committee and helpers for a very well organised and pleasant activity which was well attended.

I would also like to thank Fr Blake Camilleri for celebrating Holy Mass on site.

22/07 – LCA – 30TH Anniversary Dinner

Attended a dinner held by the Local Councils Association at The Upper Barrakka so as to celebrate the Local Councils' 30th Anniversary

25/07 – Regional Meeting CEO Transport Malta

A meeting for mayors From Regjun Lvant was held with the CEO of Transport Malta,. During this meeting mayors spoke about matters and issues that local councils deal with on a daily basis, like permits, works, timed & residential parking, MC bays, works carried out by contractors.

It was agreed that communication between TM and local councils should improve.

11/08 – Meeting with the Community Police & Lesa

Discussed various issues, particularly those related to garbage, traffic, e scooters and night noise disturbances.

17/08 – Meeting with the Hon Minister Owen Bonnici – Minister for National heritage, The Arts and Local Government & Hon Alison Zerafa Civelli – Parliamentary Secretary for Local Government.

In attendance The Executive Secretary, Ms Clarissa Buhagiar Hon Bonnici and Hon Zerafa Civelli invited us to attend this meeting so as to discuss the garbage problem in the locality.

We explained that we have been tackling the problem for the last 7 1/2 years, that is since we introduced organic waste separation. We explained that the main contributors to the garbage problem are short let apartments and in particular the cleaning of these apartments.

We stressed that we cannot tolerate this problem any longer and we asked for aggressive measures to be taken, both with regards to enforcement but also with the issuance of licences.

We informed the minister that we are convinced that several apartments and houses are being let out on a short let basis without the owners obtaining the required licences. There are instances when residences are being sub let and hence they will be off the radar.

It is worth noting that in the case of short lets, these must be registered with MTA and also with the vat department. Vat at 7% should be charged on such rentals.

We insisted that local councils should know who the administrators of apartments are so that we could work closely with them and tackle any problems that may arise.

The minister informed us that the Commissioner for Data protection is against this measure. We protested about this and we insisted that tis is not right. At this stage the minister invited me to meet the Data Commissioner may be I could convince him.

I refused this outright and I insisted that Central Government should convince that Data Commissioner that there was nothing wrong in informing the local council and even the public in general who is the administrator of a block of apartments.

I am sorry to state this but it seems that it will be a very long time before we could find and end to the garbage problem/crises !

18/08 – Meeting with Ing David Bonanno from Enemalta

I met Ing Bonanno from Enemalta so as to se what could be done so as to improve the electrical and other wiring maze and mess that there is in Swieqi road.

He informed me that he will be presenting a report as to what could be done from Enemalta' s end. However he pointed out that besides wires belonging to Enemalta there were also wires that belong to Telemalta, GO and Melita, some of which may be dead wires.

I kindly ask the Executive Secretary to set up meetings with Telemalta, GO and Melita so that this issue could be tackled with them too.

21/08 – On Line Meeting with ERA & MTA

In Attendance Councillors Alex Chetcuti and Edgar Rossignaud and the Executive Secretary Ms Clarissa Buhagiar.

The garbage problem was discussed in detail.

Both entities showed commitment and determination to help us solve the problem.

We explained that the situation has now reached unbearable levels and that both entities should use the most aggressive

methods possible so as to solve the garbage crises that we are facing.

MTA offered to instal cameras as long as these are monitored by Lesa.

They informed us that from reports presented by the local council to them, they have found several apartments/residences operating without the necessary licences & permits.

ERA assured us that they are carrying out several inspections and after spending time trying to educate people they have now started to fine wrongdoers. They too shall be approaching Lesa so as to find out how they could collaborate and enforce together.

We suggested that both entities come to work from the locality in tandem with the local council.

They agreed to collaborate with the local council

23/08 – Meeting with Ms Cynthia from the department for Active Ageing

In attendance councillor Theresa Valentino and the Executive Secretary, Ms Clarissa Buhagiar

We discussed the possibility of improving the services offered since these are in great demand.

OTHER MATTERS

Application for an Old Peoples' Home in Triq il Gejza/Sweiqi rd

Some resident are adamant that an old peoples' home should not be built in tri il Gejza. They are against the construction of anything that is of a commercial basis since this will form a dangerous precedent

I tried to explain that an old peoples' home will be less invasive than a block of flats that will be rented out on a short let basis.

However they would not listen.

I am informed that the PA hearing is on the 2nd September.

Shall we organise a meeting for residents about the subject matter, or meet these people who are opposing the construction of an old peoples' home ? or jus oppose the development outright ?

Madliena Environmental Trail

Today whilst I was at the local council in meeting with Clarissa i received a call from Mr Gerald Vella from GAL Majjistral. He expressed his annoyance about the fact that after all the work that has been carried out, not only haven' t works started but it appears that we are having second thoughts about the project.

He asked us to get on with the project.

Triq il Giebja/Josef Kalleja

The saga has now been going on since November 2022 and unfortunately we are still without a solution.

Residents re extremely annoyed and frustrated about this and they are absolutely right. Not only have they

been excluded from the locality that they live in but they are living in a very unsecure environment.

The Notary says that he needs a report from Architect Falzon. Architect Falzon says that he needs a report from Clarissa. Clarissa maintains that she prepared the work that she had to prepare. I kindly ask Councillor Edgar Rossignaud to take charge of this issue and to make sure that the matter is resolved without any further delay.

E Scooters

I still see people riding e scooters wrong way. We also still witness scooters parked in a hap hazard manner.

4 years since their introduction no parking bays have been identified and allocated to them as yet.

The local council proposed parking spots to TM. However these were not accepted by TM. The latter have now asked the operators Bolt and Bird to suggest parking spots. It appears that Bolt have submitted their proposals but Bird have not.

I kindly ask the Executive secretary to push for a solution.

Air Quality Reports

We have received reports from the air quality devices that have been installed in the locality.

We now need to find someone who can interpret these reports !

St Andrews Road Works

Road works in St Andrews road are progressing.

Yesterday IM applied certain deviations in triq il Qasam which caused traffic havoc. Unfortunately we were not informed about these deviations.

Last night I forwarded traffic deviation proposal to IM.

Sleeping Policemen Triq Pedidalwett
