



**Council meeting 18.09.23**

**Meetings held / attended**

**25/8 – Meeting with Judge Scicluna re Gieh is Swieqi**

**Judge Scicluna presented informed me about this year' s winners and proposed some amendments that will be discussed by the Organising Committee**

**25/8 – Meeting with ERA & MTA re garbage problems**

**Present, ERA CEO, Mr Kevin Mercieca and Enforcement officer Ms Aimee Buhagiar and representatives from MTA, Mr Kevin Fsadni, Mr Mark Scerri Simiana and Ms Nicola Caruana**

**This meeting was held at the request of ERA CEO Mr Kevin Mercieca.**

**During this lengthy and frank meeting we discussed various issues related to the garbage crises that we are facing.**

**I wish to thank Mr Mercieca for listening to our issues and for the action that is being taken on reports that we are submitting to the authority. I also wish to thank MTA officials since they too are inspecting various premises that we have been reporting.**

**It must be noted that MTA have identified several residences that were operating without the necessary permits.**

### **Court evidence / Oath**

**It must be pointed that whereas reports made to the police and Lesa must be corroborated by court evidence, in the case of reports made to ERA , the authority will prosecute the wrong doers as long as the person making the report takes an oath at the ERA offices.**

**28/8 – East Region - Region of Culture 2024**

**The East Region has been chosen as the Region of Culture 2024.**

**The launch was made at our Council' s Hall in the presence of the Hon Minister for Culture, Heritage & Art and Local Councils, Hon Owen Bonnici, Parliamentary Secretary for Local Councils, Hon Alison Zerafa Civelli, Director General Ms and the President of the Eastern Region Mr Anthonng Chircop. Aso in attendance were members from various local councils that from part of the Eastern Region.**

**29/8 - Residents' meeting re Old Peoples' Home ( OPH) in triq il Gejza/Swieqi road**

**A meeting was held for residents, particularly those who live in the vicinity of the site where the developers plan to construct the OPH .**

**An interesting discussion ensued. However it was evident that the majority of those who attended were against the construction of the OPH.**

**The main reason being that the policies do not allow the construction of an OPH in a residential priority area.**

### **31/8 – Meeting with TM re Slow Streets**

**In attendance, Perit Conti and Mr Debono from Transport Malta and Perit Dieter Falzon and the Executive Secretary, Ms Clarissa Buhagiar.**

**We explained to Transport Malta our plans for Slow Streets.**

**We emphasised that priority should be give to the installation of cycle lanes in Victoria Gardens, as well as the introduction of Slow Streets in triq is - Swieqi , Triq il – Qasam and Ibrag road.**

### **1/9, 2/9 & 3/9 – Swieqi Fest**

**I wish to heartily thank the organisers of this year' s edition of Swieqi Fest. The hard work put in by the**

**councillors involved, council staff, the numerous volunteers, the Art group and the director/organiser were truly impressive.**

**A word of thanks must also go to the numerous sponsors.**

**I must admit that the whole event was very well organised and very successful.**

**A note of special thanks must go to the volunteers in the Bar and Kitchen area.**

**I was amazed with the way that the kitchen volunteers and Executive Secretary reacted when a fire accident that occurred in the kitchen area on the third day disrupted proceedings. During this introductory meeting with the new works contractor, we discussed the outstanding works that need to be carried out, such as pavement repairs and the embellishment works in Gnien Maurice Caruana Curran.**

## **Road Works**

### **Triq il Hemel**

**Road works in triq il Hemel are progressing at a snail's pace. Works commenced over 5 months ago, which means that residents have been enduring dust issues and inconveniences for such a long time.**

**When one considers the relatively short length of the road, this delay is unacceptable.**

**Residents are up in arms and fed up. And rightly so. I have been regularly drawing the attention of Infrastructure Malta about these delays and the 'stone age' work methods that are being applied. It is evident that the contractor does not have sufficient workers to carry out the job swiftly and efficiently.**

### **Triq il Giebja/Josef Kalleja**

**Unfortunately we have not yet been presented with the required reports from the Notary who was assigned to do the job. This is another frustrating situation.**

**Residents who live in triq Josef Kalleja have been denied access to the locality for nearly one year and this is absolutely not right. I excuse myself for the great inconvenience that has been caused to them. We**

**I kindly ask the Executive Secretary to chase the Notary and to obtain the report that is required by PA and IM.**

### **Advertising Boards**

**It appears that the advertising boards have not been leased out yet. Could those involved accelerate the process please.**

### **Council' s Electric Van**

**Two quotations for an electric van have been obtained. We need the assistance of someone who some**

**knowledge of electric vans to advise us which vehicle is the most suitable to our needs.**

### **New Bins**

**We have managed to obtain six new bins from the Cleansing Department and we hope to obtain others from MTA.**

**We shall be replacing the metal bins that are situated in Swieqi road. These in turn will be installed elsewhere in the locality.**

### **Berga & Influenza Jab**

**We have once again asked the Health Department to help us reopen the Berga and to offer the Influenza Jab next month.**
