### **COUNCIL MEETING 20.11.23**

18.10.23 – Meeting with Mr Pollacco – Triq il Pulzier

Mr Pollacco wanted to inform me about this Invasive plant that is spreading rapidly and enshrining/overpowering other plants and trees in triq il Pulzier. It has literally engulfed a very high palm tree. Apparently it may be damaging for ones health.

We have written to ERA about this tree and they have no problem with this tree/plant being removed. The issue is that this plant is in private property. Besides who is going to pay for the costs of its removal ?

19.10.23 – Meeting re zebra crossing in triq il Keffa

Present Councillor Rowena Scicluna and Executive secretary.

The location where to place the zebra crossing in triq il Keffa was identified. Application presented to TM.

20.10.23 – Talk at the Church

I was invited to give a talk about the functions of the local council to residents who gather on a monthly basis at the Church

## 26.10.23 – Gnien Maurice Caruana Curran - Meeting with the Gardener & Contractor

The retaining wall of the garden on the side of triq il Hemel needs to be replaced due to the fact that the wall is damaged and may collapse. It was noted that the damage has been caused by the roots of the trees that planted all along the said wall. There are about 7 of them. There are two issues. One, once the wall is removed, the trees risk falling over. So as to avoid this risk they need to be tied to some cement planks. However, in all probability the roots will eventually damage the new wall too. The trees are ..... and they are not protected trees. Actually there are harmful to whoever suffers from asthma. We have contacted ERA and there should be no problem with replacing these trees with indigenous trees such as Cypress. I am of the opinion that we should go ahead with replacing these trees and with planting others on the inner side of the garden.

There are another two similar trees on the pavement in triq is Sejjieh. The roots have literally uprooted the pavement and there is no way we could repair the pavement without uprooting these trees. I suggest that we replace these two trees with a larger planter that will house 4 or 5 Cypress trees. Once they grow they will form a nice green wall

31.10.23 – meeting at PA re triq il Giebja/Josef Kalleja

In attendance Perit Dieter Falzon and Notary Justin Fenech.

The PA officials have now asked for the ownership of the land where the steps were meant to be built !!!

31.10.23 – meeting at IM re projected road works in the vicinity of the Swieqi road tunnels

In attendance councillor Perit Rossignaud.

IM architects briefed us about the plans that are still at draft stage. They were not keen to forward copies of these plans to u.

31.10.23 - - Caritas talk re use & abuse of Synthetic Drugs

Officials from Caritas and an Inspector from the Drug squad gave a very detailed presentation about the various types of drugs, their use, abuse and dangers. They stressed on the dangers of the use of synthetic drugs and they advised how one should deal with users, particularly children. They offered very worrying statistics about children who start experimenting with drugs from a very young age, even from the age of 12 years.

It was a pity that a very few people attended. In my opinion the talk should be repeated in the near future, but we should make sure that more people will attend.

### 31.10.23 – Halloween

It appears that the police handled the event successfully. I am not aware of any particular incidents.

### 01.11.23 – meeting re Berga

In attendance the Executive secretary. We met an official from the health department so as to discuss the possibility of reopening the services of the Berga.

We were informed that since Covid they have introduced new regulations and standards. One of these is that the Berga should have an independent doorway. This should not be a problem in that one of the windows could be turned into a door.

What may be an issue is that they would require to make use of both rooms, which means that we may not be in a position to offer certain services any longer or we will need to identify a new location/create new space.

Unfortunately the PA board voted unanimously in favour of the development. We are considering whether we should appeal this decision.

It must be noted that the local councils of San Gwann and St Julians joined forces with our council in opposing this project and they are prepared to support an appeal if sufficient grounds are available.

The three local councils issued a joint press release the day before the hearing informing the public that the 3 local councils were not in favour of this development.

20.11.23 – Talk by the Community Police re Crime Prevention

Community Police organised a talk for residents during which they informed residents on how to prevent and also report crime. The event was well attended.

## **OTHER MATTERS**

### **ROAD WORKS**

Triq il Mizura – works from triq tal Franciz to triq il Keffa have been completed. Works from triq il Keffa to triq l-lbrag have been postponed pending the completion of the road works in St Andrews road.

Triq il Hemel

Works have been completed.

Triq is Sirk/Migbed/Hemel

The second layer of tarmac still needs to be laid in Sirk and Migbed whereas the trench in lower Hemel needs to be resurfaced too.

We have repeatedly asked the contractor when they plan to proceed with the works but they will not commit. Only today a resident informed me that she fell in triq is Sirk and she fractured her ankle.

Triq il Qasam

The surface of triq il Qasam, next to Restyle Café and triq il Qantar is in a terrible and dangerous state. The road is collapsing and major repairs are required. The estimate prepared by Perit Falzon shows that the repairs will cost more than € 100K. we certainly afford this expense and we are trying to source the required funds.
