## **SWIEQI LOCAL COUNCIL**

**COUNCIL MEETING 12/02/2024**

### **MEETINGS HELD / ATTENDED**

#### **17.01.24 – Infrastructure Malta – Re ENTRY INTO TRIQ ID DRIS**

In attendance – councillor Perit Rossignaud. Perit Walter Portelli called this meeting so as to inform us that during the next phase of road works in St Andrews road, they may have to close accessibility into triq id Dris for vehicles heading south due to the fact that the road may be reduced to one lane on account of pending road works. South bound residents wishing to access triq id Dris may access via triq il Qasam / Tiben.

#### **18.01.24 – WASTE WORKING GROUP MEETING – REGJUN LVANT**

The first waste working group meeting was held. Several stake holders were present during the meeting, thus Sliema LC Mayor, Lesa, the Police, ERA, Green Pak, Green MT and others. MTA did not attend, whereas Cleansing Malta asked to be excused on account of some urgent matters that cropped up.

During the meeting we stressed on the need to find a short term solution before the tourist high season kicks in. We also pointed out that the challenges faced by every locality are different and hence we require different solutions. It was agreed that we are against 'rapid interventions' by the Cleansing Department since

**this will encourage people to take out waste on the wrong day and time.**

**The next meeting will be held on 15.02.24.**

#### **18.01.24 - MEETING WITH THE COMMUNITY POLICE**

**In attendance Sergeant DENISE Vella, Vice Mayor, Mrs MaryAnne Abela and the Executive secretary, Mrs Clarissa Buhagiar.**

**We discussed current issues like night disturbances, over speeding and the use of hand held speed guns and garbage problems, besides others.**

**Sergeant Vella stressed on the need that residents call the St Julians police station to draw the attention of the police of anything going wrong. She also noted that unless residents make an official report there will not be a follow up to anything incident.**

**It must be noted that since the meeting Sergeant Vella has been transferred to another locality and Sergeant Melissa Cardona has been appointed in her stead.**

**May I take the occasion to thank Sergeant Vella for the work carried out in the locality and we wish Sergeant Cardona**

#### **24.01.24 – MEETING WITH IKLIN MAYOR**

**I met the Mayor of Iklin so as to discuss the issue with regards to the tarmac plant. Incidentally he had just received a report from the Ombudsman regarding the same issue. Basically as things stand, emissions from tarmac plants do not seem to be regulated and the Ombudsman urged ERA to solve the problem soonest possible.**

**We agreed that before taking some form of stand, a meeting be held with the minister of the environment.**

#### **24.01.24 – MEETING RE ADVERTISING BOARDS**

**In attendance Vice Mayor, Mrs MaryAnne Abela, Councillor Mrs Rowena Scicluna and the Executive secretary Mrs Clarissa Buhagiar.**

**Agreed to distribute the boards between the 4 applicants and to explore the possibility of adding more boards in the commercial areas.**

**Several boards were removed by the contractor working in St Andrews road. The Executive secretary will check whether the contractor will re instal these boards and to obtain quotations for the installation of new boards.**

#### **25.01.24 – MEETING RE EU FUNDS**

**Meeting with Ms Maria Vassallo from Regjun Lvant on the possibility of organising activities funded by EU funds.**

**In attendance Vice Mayor, Mrs MaryAnne Abela and the Executive secretary.**

**Various projects and options were discussed. Agreed to keep close contact and follow options and possibilities.**

## **25.01.24 – MEETING WITH INFRASTRUCTURE MALTA RE SWIEQI/ST JULIANS PROJECT**

**Officials from Infrastructure Malta, including CEO Mr Ivan Falzon, made a presentation on the proposed new network in the Swieqi / St Julians to the Local Council.**

**Queries put forward by councillors were replied to. It was agreed that a meeting with residents will be held shortly.**

## **26.01.24 – MEETING WITH RESIDENTS FROM TRIQ JOSEF KALLEJA**

**In attendance Perit Dieter Falzon, Notary Justin Fenech and the Executive secretary, Ms Clarissa Buhagiar.**

**Residents explained their frustration at the fact that it is taking so long for the council to obtain the necessary permits to change the planned steps leading from triq il Giebjja to triq Josef Kalleya into a road.**

**We explained that the council is equally frustrated about the time being taken and that we are not only worried about the accessibility into the locality of residents living in Josef Kalleja but we are also very worried about the security issues in that area.**

**Perit Falzon and Notary Fenech explained the technical issues involved.**

#### **29.01.24 – MEETING WITH THE HON PRIME MINISTER**

In attendance the Hon Prime Minister, Hon Minister Owen Bonnici, Parliamentary Secretary Alison Zerafa Civelli, Councillors and the Executive Secretary.

## **OTHER MATTERS**

### **ROAD WORKS**

#### **SIRK/MIGBED/HEMEL**

**Road works have been completed and line markings are practically completed too.**

#### **ROAD HUMP IN SIRK/GEJZA**

**Unfortunately the road hump that we had agreed to in the corner Sirk/Gejza was not installed, since the newly appointed architect in charge of the works was of the opinion that a permit from TM had to be obtained. This road hump would have decreased the water that flows into Gejza and causes flooding problems to some residents. We are following up the issue.**

## **TRIQ IL – MIZURA**

**The state of triq il Mizura, from Keffa to Ibrag road is in an atrocious state. It was in a terrible state 3 years ago, one can just imagine what an awful state it is in today !!**

**IM had postponed road works in Mizura until works in St Andrews road were in progress. We have been chasing IM to resume works for practically two months now and we still have not been informed when works will resume. This is simply not on and we cannot treat residents in this way.**

## **TRIQ il- QASAM**

**Part of this road is in a terrible and dangerous situation. We have asked all the entities to help us finance the cost to repair the road, including the Hon PM. What we have been offered by IM is that they repair this road in exchange of other road works that they ought to carry out in the locality.**

**We are of the opinion that this is totally unfair and unjust. If the local council is responsible to carry out major road repairs, then we should have sufficient funds to pay for them. We simply do not have the funds to pay for the costs involved. We need to take a decision on this matter soonest possible.**

## **PROJECTED SWIEQI / ST JULIANS ROAD WORKS**

**GIZIMIN/JOSEF KALLEYA**

**GIZIMIN/SWIEQI RD/QASAM/PELIKAN**

**We are all aware that these major works will cause serious traffic disruptions.
