66.3.2 Nhar l-14 ta' Frar, is-Sindku flimkien mal-Onor. Zerafa Civelli ingawguraw ufficjalment il-ftuħ tal-clubhouse fi Triq is-Sejjeħ. Dan il-bini se jkun qed jintuza mill-għaqdiet sportivi bħala ufficċju amministrattiv. Għal din l-attivitá kien hemm prezenti wkoll il-Viçi Sindku, il-Kunsillieri M. Bonello, R.Scicluna, A. Pisani flimkien mad-Direttur Ġenerali Sur E. Vassallo.





MEETINGS HELD/ATTENDED

26.03.24 – TALK BY CANCER SURVIVORS

01.04.24 – MR HENWOOD FROM ERA

In attendance, architect Dieter Falzon, gardener Chrles Mifsud, contractor Simon Muscat and Mr Henwood and another gentleman from ERA.

We discussed the issue of the roots that have uprooted the pavement in triq is Sejjieh and are damaging the boundary wall in triq il Hemel.

The damage is evident and even though we informed ERA that we shall be planting more trees they are still not convinced that the trees should be removed. In their opinion the roots should be trimmed. Perit Dieter informed them that he will not take responsibility of any damages that may be caused in the event that someone gets injured.

We are waiting for ERA to send us their report.

ROAD WORKS

MIZURA

Works in triq il Mizura are progressing at a very slow pace. Works commenced on 01.04.24 and during this time only works in the section Ibrag road/triq il Kartocc were carried out.

We have written to the IM architect in charge about the slow pace with which works are being carried out.

WIZNA / BARMIL

Council had accepted that part of these roads will be resurfaced/patched.

We are waiting for the contractor to confirm when works can commence.

OTHERS ROAD WORKS

We have repeatedly written to IM asking them to confirm which roads they plan to resurface this year. We have been asking them for this information since last January, and even though we are in the fifth month of the year we still do not know which roads are going to be resurfaced.

We have provided them with the list of the roads that in our opinion need to be resurfaced in the short term, thus :

Triq il Ghajn

Triq il Horza

Triq il Ktajjen

Triq il Faxxina

Triq il Moletta

Triq il Ghamad

There are some roads where WSC plan to carry out works and they had assured us that they would be resurfacing the roads themselves, thus :

Part of triq il Hemel – from Sirk to Gwielaq

Triq fuq Gonna

We have been chasing WSC to inform us when they plan to start carrying out the works, but to date we have not received any confirmation.

EMBELLISHMENT WORKS

GNIEN MAURICE CARUANA CURRAN

The first phase of the embellishment works have been completed. I am very please with the outcome.

The second phase involves civil works, which include the repair of the pavement in triq is Sejjieh, corner with Qatta, where we plan to construct a larger planter, the replacement of the boundary wall in triq il Hemel and the reconstruction of the two entrances. Works cannot proceed until a decision is taken as to what can be done to solve the damage being caused by the roots of the trees.

We are building a boundary wall so as to remove the danger that there existed.

We are chasing the Health Department to confirm whether they still plan to go ahead with the opening of the clinic in our premises, however they are not replying our e mails. I have a feeling that they are having second thoughts/ if this is the case we will write to the Health Minister.

The locality needs the service of a clinic.
