Il-Minuti tas-Seduta Nru 30 ġew approvati. Il-Kunsillier T. Valentino ipproponiet u l-Viċi Sindku ssekonda.

31.2 PUNTI LI JOHORGU MILL-MINUTI

31.2.1 Il-Kunsillier A.Pisani staqsiet jekk hemmx xi indikazzjoni meta se tiġi ttrimjata is-sigra fi Triq il-Faxxina k/m Triq il-Qasam. Is-SE infurmat li se terġa' tfakkar lill-kuntrattur.

- Apparti li żgur m'hemmx fondi biżżejjed biex isir dan l-*outdoor lift*

31.3.12 Is-Sindku nforma li lllum stess irċvejna b'mod uffiċċjali mill-ERA li nistgħu nipproċedu bil-qluġħ tas-siġar tat-tieni fażi tal-ħajt ta' Ġnien MCC. Sfortunatament mir-rapport tal-persuni tekniċi jidher b'mod ċar li dawn kellhom jinqalgħu wkoll.

31.3.13 Is-Sindku nforma li l-Kunsill irċieva l-allokkazzjoni finanzjara għas-sena 2026. L-allokkazzjoni totali tammonta għal €993,950.00. ROAD WORKS

TRIQ IX XIBER

Works in triq ix Xiber have commenced and they are progressing well.

Meanwhile, traffic has been deviated through nearby triq Vidal. This road was already in a bad state, however due to the continuous flow of heavy vehicles the road has deteriorated to unacceptable levels. We have now included it in our priority list of roads that need to be upgraded with urgency.

TRIQ IL BRAMEL

The first year of tarmac has been laid.

TRIQ IL HEMEL

Works in triq il Hemel are at an advanced stage. Works on the pavements and the parking areas have been completed. Repairs on a section of the drainage system have been carried out. Soon the road will be scarified and the prepared for the laying of the tarmac.

It must be noted that the cost of the activities is financed by Department for Local Councils.

CHRISTMAS LIGHTS

As in previous years we decorated part of Swieqi road, parts of triq il Qasam, part of lbrag road and part of triq l-Uqijaas well as our four public gardens, Gnien Maurice Caruana Curran, Gnien Mons Victor Grech, Gnien Esprit Barthet and Gnien F X Ebejer.

I suggest that next year we will light up triq il Qasam from triq il Keffa to triq il Faxxina.

The cost of these decorations was financed by the Malta Tourism Authority and Regjun Lvant

FLU JAB

The Flu Jab was successfully administered at the council premises. We wish to thank Ms Mary Dimech, the nurse who very kindly and efficiently delivered the service to 200 people.

CHAIR LIFT

Unfortunately no progress has been registered with the installation of this lift. CRPD are insisting that we re instal an outdoor lift and not a chair lift. This means that :

- 1) We will loose the funds that we have available for a chair lift.
- 2) We will need to issue another tender of the purchase and installation of an outdoor lift, which means a further delay of several months
- 3) We do not have the funds available for an outdoor lift.

We are trying to set u a meeting with CRPD and minister Julia Farrugia to try and solve this very sad issue which has dragged for too long and which has deprived people with mobility problems to attend and participate in the activities that are organised in the Council Hall. This is simply not right.

RETAINING WALL IN TRIQ IL HEMEL

Today we received a notification from ERA that we can proceed with the removal of the remaining trees that are causing structural damage to the retaining wall in triq il Hemel.

FINANCIAL ALLOCATION FOR BASIS YEAR 2026

The Department for Local Councils has sent us details of the Financial Allocation for Basis Year 2026. The total allocation is of € 993,950 which is practically at par with that of last year. For the first time we have received € 20,000 to fund touristic zones.

I am convinced that due to the steep increase in the cost of services and products purchased by the local council we will find it very difficult to make ends meet during 2026.. We await the budget that will be presented by the Executive Secretary for Basis Year 2026.

PHASE 2 OF THE AFFORESTATION PROJECT IN MADLIENA.

I am informed that there are EU funds available for the implementation of Phase 2 of the afforestation project in Madliena. I am of the opinion that we should apply for these funds.

Lady Marks has shown interest to finance the 20% of the cost which should be paid by the Local Council.

BREAST CANCER MEMORIAL GROVE

We have been approached by Mr Gordon Caruana Dingli, a renowned Surgeon, who heads the Breast Cancer Foundation in Malta. This year the Foundation is celebrating its 25th anniversary, and to commemorate this important event they have expressed their interest to plant trees in Madliena.

We are thankful to Mr Caruana Dingli for having chosen our locality to commemorate such an important event. We have since organised several meetings to plan the way forward. The costs of the tree planting will be paid for by the Foundation and they aim to plant the trees toward the end of December.

I am pleased to inform you that MTA have accepted to finance the cost of the replacement of the CCTV cameras that were installed in the locality about ten years ago.

The works need to be completed by the end of December

The system will be administered by LESA.

We thank MTA for their continued assistance.

NEW PLANTERS IN TRIQ IL GHAJN

IM will soon be starting road works in triq il Ghajn.

We shall be asking IM to instal two new planters in the corners of triq il Ghajn corner with triq il Ktajjen. Plans have been prepared and we have asked IM to issue the permits.

TREE PALNTING IN THE NEW PLANTERS IN TRIQ IL HAWT.

We have planted 6 different types of Etna Fire in three new planters in Triq il Hawt.

PLANTERS IN TRIQ IL QATTA

We are still waiting for Project Green to deliver the Cipress trees that will be planted in the new planters situated in triq il Qatta. Hopefully they should be delivered next week.

Project Green will also be donating 8 Etna Fire plants which are going to planted in 3 planters in triq il Qasam.

OTHER PLANNED ROAD WORKS

Once works in Hemel are completed, full works will proceed in Ghajn, Ktajjen, and Dris whereas trench repairs will be carried out in Gwielaq and Gharbiel.

On 15th December we shall be meeting IM so as to discuss pending works.

EMBELLISHMENT WORKS IN IBRAG ROAD

These works are at a legal standstill. Since PA are not financing tiling works any longer, we need to change our plans and this may cause problems with the tender specifications.

PAVEMENT REPAIR WORKS IN TRIQ IL LEBRUN & TRIQ IS SIEGH

We are chasing the contractor to start these works.

SHADES IN GNIEN F X EBEJER AND GNIEN MONS VICTOR GRECH

Perit Falzon will be preparing the design and costing for the installation of shades. The cost will be financed by funds made available by Regjun Lvant and Lesa.

REPAIR WORKS IN TRIQ L-UQIJA

Tests carried out have shown that the base of cement is in a good condition and that the damage was caused due to problems in the material that is placed under the tiles.

These repair works need to be carried out soonest possible but we need to source funding !!

REPAIRS TO THE OUTSIDE WALL OF THE COUNCIL HALL

Something must be done to repair the terrible state in which the wall next to stairs leading to the council hall is.

It makes the premises look shabby and neglected. Perit Falzon has been informed to find a solution.

UPGRADING OF THE AREA IN THE CORNER OF MADLIENA RD / MADLIENA HILL

Today we were informed that we have secured the funding of this project. We need to finalise the plans and we must make sure that we work around the finances available.
